ORDER

1. Vide paper read (1) above, Continuation of Provisional Affiliation was granted to Govt. Ayurveda College, Kannur for conducting BAMS - 73 Seats, MD (Rasashastra and Bhaishajya Kalpana) with 7 seats, MD (Kriya Sharira) with 9 seats, MS (Shalya Tantra) with 6 seats, MS Shalaky - Netra Roga Chikitsa with 3 seats, MS Shalaky - Karna, Naasa and Mukha Roga Chikitsa with 3 seats & MD (Roga Nidan avum VikritiVigyan) with 6 seats for the academic year 2025-26.
2. Vide paper read (2) above, the Medical Assessment and Rating Board for the Indian System of Medicine (NCISM), Ministry of AYUSH, Govt. of India has granted revised yearly permission to Govt. Ayurveda College, Kannur for **conducting UG (BAMS) course with 75 seats and MD (Roga Nidan avum VikritiVigyan) with 9 seats** & no changes in other PG seats.
3. Hon'ble Vice Chancellor has accorded sanction for granting affiliation to the enhanced seats. Accordingly, the University order read (1) above is hereby modified by granting Continuation of Provisional Affiliation to Govt. Ayurveda College, Kannur for conducting **UG (BAMS) course with 75 seats and MD (Roga Nidan avum VikritiVigyan) with 9 seats**, MD (Rasashastra and Bhaishajya Kalpana) with 7 seats, MD (Kriya Sharira) with 9 seats, MS (Shalya Tantra) with 6 seats, MS Shalaky - Netra Roga Chikitsa with 3 seats, MS Shalaky - Karna, Naasa and Mukha Roga Chikitsa with 3 seats for the academic year 2025-26, as per the clause 2(5) ix(16) of affiliation statute.
4. The college shall strictly adhere to the following conditions detailed below :-

i) The college shall strictly comply with the conditions prescribed by the Medical Assessment and Rating Board for Indian System of Medicine, National Commission for Indian System of Medicine, in the permission order granting yearly permission to the college for conducting UG & PG courses during 2025-26 vide letter read (2) above.

ii) Selection, admission and collection of fees shall be made only on the basis of the rules and regulation of the University / Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.

iii) In the light of the direction of the Hon'ble Supreme Court of India in Writ Petition (C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.

iv) Affiliation granted is strictly provisional and only for the academic year 2025-26. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.

v) Admission to the next academic year shall be made only after obtaining prior permission from the University.
